Guiding Laws and Regulation Under;

Yobe State Harmonize Codification Law, 2021 Yobe State Right of Way (ROW) Regulation, 2023

Client information

All individuals and organizations seeking the Right of Way (ROW) in Yobe State can apply for a ROW Approve/Certificate through the following process;

STEP 1. At Ministry of Housing and Urban Development Along Maiduguri – Gujba Road Bypass.

Opposite Don Etibet Housing Estate P.M.B 1112, Damaturu, Yobe State.

STEP 2. The completed application form should be returned together with the following documents:

- i. Evidence of registration with the Nigerian Communications Commission (NCC).
- ii. Evidence of registration with the Corporate Affairs Commission

STEP 3. Submission of application form and relevant documents

Submit completed form together with documents listed in step 2 above to Yobe State Ministry of Housing and Urban Development Damaturu.

- Application Letter
- Photo ID of the company directors: National ID Card, International Passport, Driver's License or Voter's Card.
- Passport photographs of the company directors.
- Certificate of Incorporation.
- Certified True Copy (CTC) of Articles & Memorandum of Association.
- Certified True Copy (CTC) of Form CO7 (List of Company Directors).
- Tax Clearance Certificate or Evidence of Current Tax Clearance Certificate.

- Tax Clearance Certificate or Evidence of Current Tax Clearance Certificate.
- Certificates of qualified technical staff (if applicable).
- Application letter to include: Proposed routes, Routes diagram, Distance to be covered, and completion timeline.
- A project proposal, including a list of routes, the scope of work, budget, evidence of funding, portfolio of prior fibre deployment, site survey/assessment plan, risk assessment, and occupational health and safety plan.
- Evidence of payment for Application, Processing and Administrative charges
- Letter of Engagement (If applying as a consultant for a network provider)
- Provide topo map showing the area of coverage and distance

STEP 4. Assessment of document and issuance of Demand Notice

Yobe State Ministry of Housing and Urban Development will assesses submitted documents and issues Demand Notice capturing applicable fees as captured in Yobe State Revenue (Codification) Law 2021.

Applicable fee is N145/linear meter

STEP 5. Payment of applicable fees

- i. 120 per site for Base transceiver station (BTS).
- ii. 120 per m² occupied on the ground for other installations such as street cabinets intended to house the technical installations for serving subscribers.
- iii. As per Regulation, the Yobe State Ministry of Housing and Urban Development may impose a lump sum fee in the maximum limit of N 200,000 for the installation, placing, laying or maintenance of the Network Facilities
- iv.N25,000 for Processing and Administrative Charges

STEP 6. Submission of evidence of payment

Official receipt will be issued at the Ministry on presentation of evidence of payment.

STEP 7. Application processing

Processing of application is undertaken within Twenty one working days (21 days) excluding public Holidays. Applicants will be notified of the decision on application via SMS or email within the timeline and advised to come for collection of permit.

STEP 8. Permit Collection

Applicants may collect approved Building Permit at the Yobe State Ministry of Housing and Urban Development. Damaturu. Within 9:00AM - 4:00PM Monday to Friday (excluding public holidays).

Sanctions

The breach of this Law or Regulation shall be punishable by any of the following:

- a) Fines up to 5,000,000
- b) Suspension of RoW
- c) Termination of RoW
